Definition: A relatively wide, shallow, open channel, typically vegetated with turf grasses, with a slight gradient. These systems are designed to let water flow slowly through the turf grasses. The roughness of the turf slows the runoff velocity and provides some filtration and settling of suspended solids. Runoff volumes can also be reduced through infiltration depending on the porosity of the underlying soils. Swales can be designed with underdrains to convey excess runoff from saturated soils. Pollutant removal is accomplished through filtration through the vegetation and swales are frequently designed to allow for infiltration of stormwater.
